- Obtained dismissal with prejudice of unfair competition claim against vape technology client brought by competitor.
- Obtained dismissal with prejudice of copyright claims brought by known “copyright troll” against rug manufacturer and retailer clients.
- Successfully argued and defended preliminary injunction sought against art storage client in a trademark dispute. The district court denied the plaintiff’s request for a preliminary injunction and vacated the temporary restraining order against our client.
- Obtained dismissal of patent inventorship claims against aromatic packaging client. The dismissal was affirmed by the Federal Circuit.
- Obtained summary judgment of validity and infringement in favor of AV client in patent litigation against a competitor.
- Defended and obtained summary judgment of non-infringement and invalidity in favor of a national software company client in patent litigation relating to database technology.
- Obtained jury verdict of \$105.9 million in favor of leading geophysical services company in patent litigation relating to oil drilling technology. Post-trial, the court granted a permanent injunction and awarded costs and over \$73 million in supplemental damages in the client’s favor.
- Obtained jury verdict of \$19.5 million in favor of major medical device company client in patent litigation relating to stents. Post-trial, the court doubled damages for the defendant’s willful infringement and awarded the client an ongoing royalty of 32% of product sales.
- Penned amicus briefs on behalf of trade organizations in *Minerva Surgical, Inc. v. Hologic, Inc.*, *VIP Products LLC v. Jack Daniel’s Properties, Inc.*, and *Helsinn Healthcare S.A. v. Teva Pharmaceuticals USA, Inc.*
